The Centre for Distance and Online Education was established in 2020 with the primary aim of providing comprehensive online programmes in accordance with the UGC (ODL & OL) Regulations of 2020. These online programmes will adopt a fully digital approach from inception to completion. Degrees conferred upon completion of these programmes will be considered equivalent to undergraduate and postgraduate degrees obtained through traditional means. The Centre is authorised to admit students in two sessions per calendar year, January and July, through online channels

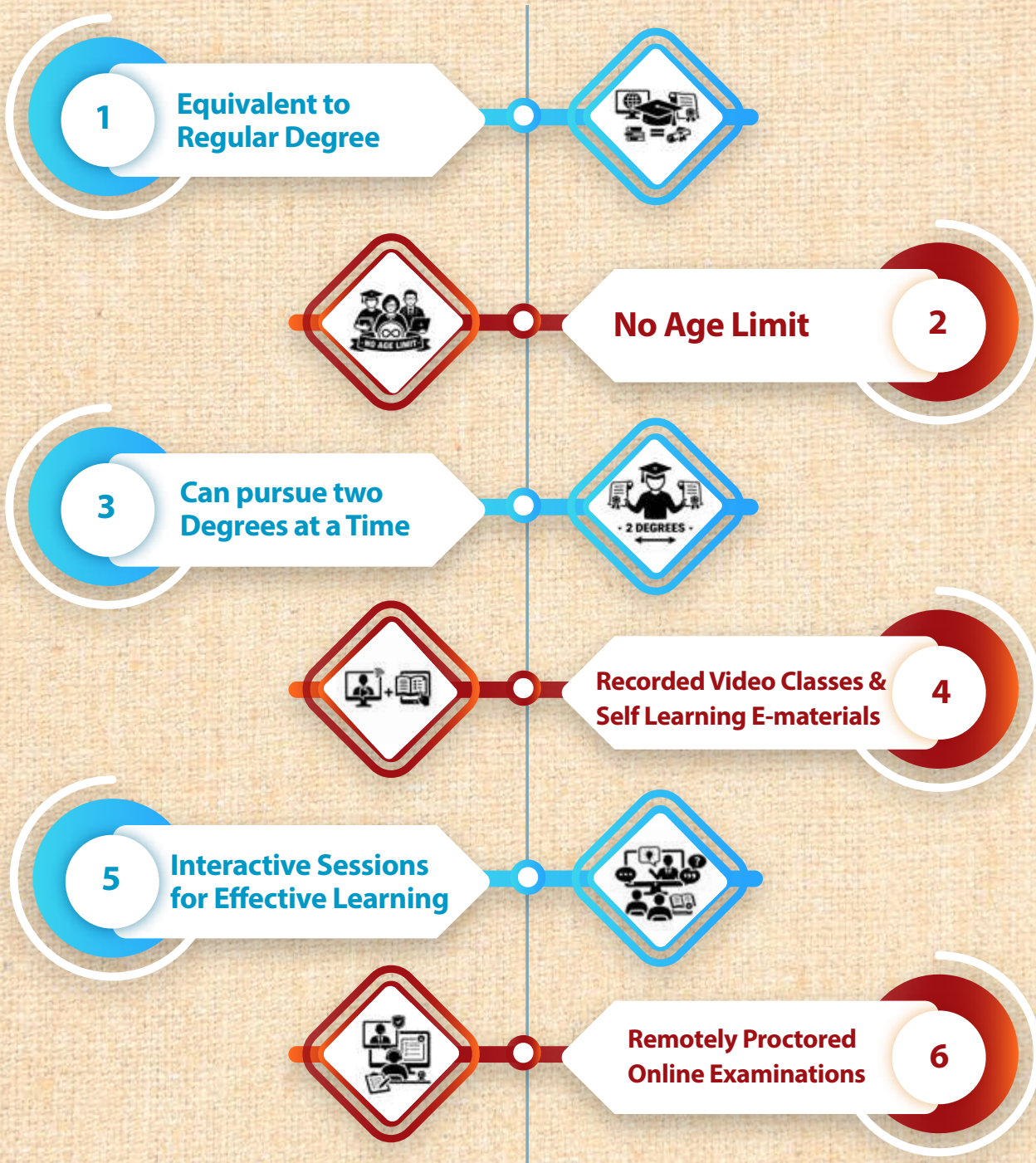

Programme Highlights



Programme Mode

The programme will be exclusively offered in a fully online format. All academic engagements will be facilitated through the Learning Management System (LMS) of MGU Online, granting students access throughout the duration of the programme. Enrolled students are expected to actively engage in online learning activities, complete assignments and participate in examinations to fulfil the programme's requirements in accordance with University regulations and course specifications.

Programme Delivery System

The entire teaching-learning process shall be conducted online through the Learning Management System (LMS) in a four quadrant approach. It encompasses of :

1. Recorded video lectures.
2. Self learning materials.
3. Live interactive sessions / discussion forums
4. Assessment
 - Internal assessments (Assignments, Quizzes, Test papers, Seminars, etc.)
 - External assessments (Remote Proctored Online End-semester Examination)

Online programmes shall also include components like projects, viva and internships according to the syllabus, and these shall also be undertaken and completed by the students on a virtual mode as per the topics assigned to them.

To be eligible to appear for the end-semester examination, the students shall have a minimum participation of 75 % in all the activities of the online programme.

Overview of the Programme

The online Master of Business Administration (MBA) Programme of Mahatma Gandhi University is designed to deliver a high quality business education that is on par with traditional, on-campus MBA Programme and to develop students into leaders and entrepreneurs who are ready to take on the challenges of an ever changing global business landscape. This online programme offers flexibility and accessibility to learners seeking advanced business and management education while accommodating their professional and personal commitments. This objective is accomplished through a combination of affluent instructional resources as well as infrastructural facilities involving various digital tools and technologies that are specifically designed to map the entire student life cycle and to deliver the programme in a panoptical mode.

Eligibility

A Bachelor's Degree of a minimum of three years duration in any stream recognised by Mahatma Gandhi University with not less than 50% marks for part III or minimum CGPA of 50% in percentage conversion or a Master's Degree in any subject.

Fee Concessions and Advance Fee Payment Discounts

The following fee concessions shall be applicable to candidates admitted to Online UG and PG programmes, subject to eligibility verification as stipulated by the University.

Fee Concessions and Required Documents

- **40% Fee Concession** – Regular (ongoing) students (other than Ph.D. scholars) of Mahatma Gandhi University are eligible for the fee concession, in accordance with the UGC regulations permitting students to pursue two academic programmes simultaneously—one in regular mode and the other in online or distance learning mode. In the case of students enrolled in the final semester of a regular programme, the fee concession shall be admissible only if the application is submitted at least thirty (30) days prior to the completion of the academic classes of the final semester.
Document Required: Certificate from the Principal confirming that the student is pursuing a regular programme under Mahatma Gandhi University. Applications submitted without this certificate will not be considered eligible for fee concession.
- **20% Fee Concession** – Regular (ongoing) students (other than Ph.D) of other universities and Government/Aided institutions. If a student is completing their final semester, they are eligible for the fee concession only if the application is submitted at least 30 days before the completion of their final semester academic classes.
Document Required: Certificate from the Principal confirming regular student status during the period of study. Applications submitted without this certificate will not be considered eligible for fee concession.
- **10% Special Scholarship** – Women / Transgender candidates.
Document Required: SSLC Certificate (for gender proof) or Transgender Certificate issued by the competent authority.
- **10% Scholarship** – Economically Weaker Section (EWS).
Document Required: Valid EWS Certificate issued by the competent authority.
- **20% Scholarship** – Differently Abled Persons.
Document Required: Disability Certificate (40% or above) issued by a competent medical authority.

Advance Fee Payment Discounts

- **10% discount** on the total programme fee if fees for all semesters are paid in advance.
- **5% discount** if fees for two semesters are paid in advance.

Note: Fee concessions and discounts are subject to verification of documents and approval by the University. Only one concession will be granted at a time.



Eligibility criteria for reservation categories

The eligibility for admissions and reservation of seats to the Programmes shall be in accordance with the norms/ rules made by the Government/ University from time to time.

Presently, the applicable relaxation is as follows:

Kerala Scheduled Caste/Scheduled Tribe Category:

The minimum requirement for admission to UG/PG programmes is a pass in the plus two/eligible degree or equivalent for the Kerala Scheduled caste Scheduled tribe category.

Kerala SEBC Category:

A relaxation of 3% marks in the eligible degree or equivalent from the prescribed minimum is allowed.

Kerala OEC Category:

A relaxation of 5% marks in the eligible degree or equivalent from the prescribed minimum is allowed.

Persons with Disability category:

The minimum requirement for admission to UG/PG programmes is a pass in the plus two/eligible degree.

- The eligibility of the candidates who have acquired a plus two from other states/qualifying degree from other Universities (for students outside India as well) shall be verified by the University and the admission shall be regularized thereafter.
- There shall be no age limit for applying to the programmes offered by the Centre for Distance and Online Education.

- Fill out the application form, including personal and academic details.
- Pay the application fee
- DEB id Validation, Documents upload & submit
- Approval of admission will be intimated.

Fee Refund Policy

If any candidate decides to withdraw from the programme in which the candidate took admission, then the university shall follow the UGC and University norms for Fee refund.

Category	Percentage of Refund of fees	Point of time when notice of withdrawal of admission is received in the HEI
1	100%	15 days or more before the formally notified last date of admission
2	90%	Less than 15 days before the formally notified last date of admission
3	80%	15 days or less after the formally notified last date of admission
4	50%	30 days or less, but more than 15 days after formally notified last date of admission
5	0%	More than 30 days after formally notified last date of admission

General Regulations

- This Prospectus has been issued in concurrence with the Admission Process for online Programme by Centre for Distance and Online Education, Mahatma Gandhi University, 2026 sessions and shall not be valid for any past or future programmes offered by the University,
- Conditions in this prospectus are subject to amendments as may be deemed necessary by the University.
- Candidates are required to go through the current prospectus carefully and acquaint themselves with all the relevant information relating to the admission process
- Candidates are requested to visit the official website of the University www.mgu.ac.in and cdoe.mgu.ac.in for all relevant information.
- Any communication from the part of mguonline will be made via the candidate's registered email id.



- The candidate shall submit the application only after proper scrutiny of all information furnished. If the application received from the student is not complete in any respect, the student may be given provisional admission at the discretion of the University. Such students will have to submit the required eligibility documents at the earliest, upon the receipt of which their admission may be confirmed, subject to eligibility fulfilment.
- In case of any mistakes / omissions, you may request a correction in your application with relevant supporting documents via the email id mguonline@mgu.ac.in at any time.
- If required, the University may conduct online meetings with the candidate at any point of time during the course of study for the verification of the eligibility documents. Non-compliance of the same may result in cancellation of admission. Any discrepancies in the certificates furnished or claims made in the application shall lead to rejection of candidature and may subsequently lead to blacklisting of the candidate / initiate criminal proceedings.
- Hard copies of the application form and enclosures need not to be sent to the University
- Payment of fee during the admission process and in subsequent semesters shall be undertaken by the candidates within the timelines announced by the University and failure to complete the same may invalidate the admission / registration at any point. Fee payment via offline modes shall not be entertained.
- The University reserves the right to amend the syllabus, programme structure, rules and regulations whenever considered necessary and appropriate for the smooth conduct of the programme without any prior notice.
- All sort of official communication from the University shall be through E mail and LMS after getting admission to the programme.
- If the application is complete in all respects and mguonline is satisfied with the applicant's eligibility and suitability for admission into the respective online programme, the student will be granted admission to that programme.





Validity of the Admission / Registration

- Similar to the offline programmes, the online Post Graduate programmes shall have a 2 year / 4 semester duration. If a student does not complete all programme requirements within the specified duration, the student is expected to complete the programme within 4 years from the date of admission. Additional examination fee shall be applicable for every additional attempts.
- The online Under Graduate programmes shall have a 4 year / 8 semester duration. If a student does not complete all programme requirements within the specified duration, the student is expected to complete the programme within 7 years from the date of admission. Additional examination fee shall be applicable for every additional attempts.
