Amendments to the same have been approved and University Orders vide papers read as (2), (3), (4), (5), (6) and (7) above were issued.

Among the various committees constituted for the smooth implementation of the Four Year Under Graduate Programmes, the Subcommittee on Rules and Regulations after detailed deliberations,, submitted recommendations, vide paper read as (8) above, to amend the MGU - UGP (Honours) Regulations, 2024. Nil	vi) Students readmitted under this section shall be assigned a Permanent Register Number
	(PRN) identical to that of the batch into which they are readmitted, and their Year of
	Admission to the MGU – UGP (Honours) programme shall be recorded as the year of their
	readmission to the programme.

Nil	vii) To be eligible for the specializations offered under the Honours regulations, a learner
	must earn the required credits by successfully completing the courses prescribed under these
	regulations. Credits earned for courses under the CBCS regulations shall not be accepted for
	the award of specializations under the MGU – UGP Honours regulations.
Nil	viii) A learner may cancel their admission to an MGU – UGP programme if they wish to
	discontinue it.
Nil	ix) After cancelling admission to a programme and securing admission to a new programme
	under MGU – UGP, the learner may utilize previously earned eligible credits, available in the
	learner's APPAR ID or DigiLocker, within the stipulated timeframe for the award of a
	Bachelor's, Honours, or Honours with Research degree.
Nil	x) A learner who opts out of an Honours programme in any semester shall not be eligible for
	readmission to the same year-of-admission batch.
Nil	xi) In the case of student' readmissions, if no seat vacancy exists, the readmission shall be
	considered over and above the sanctioned strength.
Nil	xii) The format of the Course-cum-Credit Certificate shall be as given below.

Nil	viii) Learners who opt to switch their Major to one of their existing Minor disciplines shall have				
	that discipline treated as their Major from the third semester onwards. Credits earned during the				
	first and/or second semesters in the corresponding Minor discipline shall be counted toward the				
	award of the Major degree in that discipline. To be eligible for the award of a Bachelor's,				
	Honours, or Honours with Research degree, learners must compensate for any credit deficiency				
	in the newly selected Major discipline through online or other approved modes. Learne				
	then claim their originally admitted Major discipline as their Minor discipline and acq				
	additional credits to fulfil the requirements for a Minor. Alternatively, they may select any oth				
	discipline—excluding the newly selected Major—as a Minor for completing the MGU – UGP.				
Nil	ix) Those who switch their Major to any one of the MDC disciplines shall have the credits				
	earned during the first and/or second semesters in that MDC discipline treated as credits for the				
	newly selected Major discipline. They must compensate for any credit deficiency arising from				
	Major switching, if any, in the newly chosen Major discipline to be eligible for the award of a				
	Bachelor's, Honours, or Honours with Research degree through online or other approved modes.				
	Learners may claim the credits earned in their first and/or second semester Major discipline as				
	credits for the MDC discipline, for the purpose of awarding the Bachelor's, Honours, or
